# Mandatory requirements for eligibility for election to CEHL Board

To be eligible to hold the position of CEHL Director (if elected), a nominee must:

- 1. Be aged 18 years or over;
- 2. Be a current CEHL co-op member;
- 3. In accordance with the provisions of the Corporations Act 2001 (Cth):
  - a. not be an undischarged bankrupt or have entered into a personal insolvency agreement.

b. not to have been convicted of an offence that relates to the business of a corporation or is a contravention of the Corporations Act 2001 or Associations Incorporation Reform Act 2012, or been found guilty of any offence in relation to corporate or regulatory matters.

- 4. Currently reside in a co-operative property (ie. the co-op is your principal residence);
- 5. Hold a **Director Identification Number** at the time of submitting their application for nomination to the CEHL Board [*NB*: there is no charge in applying for a DIN and if you need assistance please contact: Rachel@cehl.com.au. **CLICK HERE** if you need to apply for one].
- 6. Every prospective CEHL director must successfully pass a National Police, Bankruptcy and background checks before the Nomination for election to the CEHL Board is accepted.
- 7. Have attended at least one **Prospective Director Info Session**.
