Frequently Asked Questions

Q	Can I vote more than once?
Α	No, when you vote your name is recorded on the official voter roll as 'voted'.
Q	Can I change my vote?
A	No, so please make sure you are certain about your choices, do not vote unless you are sure.

1. Welcome and Acknowledgement of Country

Heidi Lee, CEHL Elected Director and Chairperson began the meeting with an Acknowledgement of Country: Our meeting today is being held on the traditional lands of the Wurundjeri people of the Kulin Nation, we wish to acknowledge the traditional custodians and we pay our respects to Elders, past, present and emerging. I also acknowledge CEHL Board Directors who are present today.

Housekeeping:

Brad Hosking outlined the agenda for the meeting and stated that the meeting is recorded, only speakers and presentation slides will be visible in the recording. The video recording of this AGM will be made available on the CEHL website.

Brad thanked the co-ops that have sent through questions in advance, adding that there will be an opportunity for other questions at the end of all presentations. Questions will be responded to as the time allows including those submitted in the chat function during the meeting.

In accordance with CEHL Constitution and ASIC rules, voting will be conducted:

- by poll
- by secure survey for the election of directors, and
- by proxy
- Proxy votes have been received; and
- Co-op Authorised representatives where the co-op has not pre-voted will vote by poll and survey in the meeting.
- Samantha Winter, a CEHL Appointed Director, is scrutinising the voting process on behalf of the Board.

2. Co-op vote on minutes of the 2020 AGM

Heidi Lee proposed the following motion to the members:

MOTION

THAT the minutes of the Annual General Meeting, held on 28 November 2020, be accepted as a true and correct record.

The resolution missing from last year's minutes was: That PKF be appointed as CEHL's auditor for the 2020/2021 financial year which will now be inserted into the official minutes for last year's AGM.

Heidi Lee confirmed that the Motion to accept the minutes of the 2020 AGM has been passed.

3. Chairperson's report

Heidi Lee delivered the chairperson's report Heidi:

- Thanked the CEHL Board Directors and committee members, acknowledge the contribution of all co-op members to co-ops and CEHL employees through the many unexpected turns that was 2020 & 2021.
- Acknowledged the members of Company Rent and Affordability Benchmark Advisory Group.
 Following the resignation of some committee members in 2019/20, the remaining two members closed out the committee's work supported by the Policy Advisory Committee and the Co-op Program Committee the Group concluded in December 2020.
- Acknowledged the members of CPC for establishing their engagement principles and process for engagement of key program projects.
- Acknowledged the contribution of PAC members who have worked hard to ensure a co-op voice in important Program Policy work.
- Each year CEHL Scholarship Program provides \$2,000 study grants to people living in our co-ops to further their education. This year 9 scholarships were awarded.
- On behalf of the Board Heidi acknowledged the significant contribution Karren Walker has made to her co-op and the Co-op Housing Program and the broader co-operative sector.
 - Karren has been an active member of her Housing Co-operative since she became a member in 1988 (33 years ago).

Karren was elected to the Board of Directors at Common Equity Housing Ltd in 2005 and was our Chairperson for 9 years. This was during a period of major growth of the program.

In 2018 Karren's contribution to the co-op sector was recognised by the Business Council of Co-operatives and Mutuals when she was inducted into the BCCM's Honour Roll.

Karren has significant experience in the delivery and management of client-focused service, responses to those experiencing homelessness and other at-risk households in our community.

We acknowledge the outstanding contribution she has made, and continues to make, to the lives of others.

Karren Walker spoke for a few minutes accepting the award.

Heidi spoke to the Board's achievements for 2020/2021:

- Maintained 25% affordability benchmark, with the Board endorsing member feedback through the Company Rent and Affordability Benchmark consultation.
- Established the Co-op Program Committee, to provide advice and recommendations to the board regarding, program direction and development, co-op engagement managing change and communication, emerging issues for co-ops.
- Strategic Plan Towards 2025 sets a clear direction, the Co-op Program Committee provided advice and recommendations to the board regarding, program direction and development, co-op engagement and managing change and communication, emerging issues for co-ops.

The members were shown the strategic plan video

Heidi Lee introduced Liz Thomas, CEHL's new Managing director

4. Managing Director Introduction

Liz Thomas, CEHL's new Managing Director introduced herself to the meeting noting that priorities for the 2022 were:

- Respond to feedback from co-op surveys
- Improve Board and co-op communication, and reporting
- Work with the Housing Registrar to address 2020/21 performance assessment issues
- Develop CEHL's role as a co-op housing ambassador
- Proactively engage with internal and external stakeholders
- Build on internal culture of excellence and integrity

Heidi Lee handed the Chairing of the remainder of the AGM to the CEHL Company Secretary, Brad Hosking.

5. Election of Directors

Brad announced that we had received 24 proxies and there are 4 appointed representatives voting, these 4 people have been sent a secure survey link. Samantha Winter will confirm the vote count and announce the successful nominees.

There are 4 nominees for 3 available positions on the board.

The director nominations are:

- Fiona Herman of Endeavour CERC
- Heidi Lee of Merri CERC
- Judy Reid of Phoenix CERC
- Robyn Evans of Merri CERC

I now invite the nominees to say a few words in support of their nominations:

- Fiona Herman spoke to the members in support of her nomination
- Heidi Lee spoke to the members in support of her nomination
- Judy Reid spoke to the members in support of her nomination
- Robyn Evans spoke to the members in support of her nomination

The vote for directors was carried out by a secure survey link for appointed co-op representatives where their co-op had not pre-voted on the co-op's proxy.

The votes will be added to those already received by proxy and will be advised by our scrutineer, Samantha Winter, CEHL Appointed Director.

While the vote is confirmed there were several presentations, Brad welcomed Louise Crabtree-Hayes.

6. Articulating Value in Housing Co-operatives

Associate Professor Louise Crabtree-Hayes, Principal Research Fellow at Western Sydney University and lead on the Articulating Value in Housing Co-ops Research spoke to the members about the research that is being carried out. Wendy Stone from Swinburne University of Technology who is the person on the ground in Victoria working on this important research also spoke to the members introducing herself.

7. Co-op Program Committee Report

Gillian McFee spoke to the Program Committee Report noting that the committee had:

- Established engagement framework
- Provided feedback on upcoming engagement
- Strong contribution to development of the new Strategic Plan
- · Strong contribution to recruitment and induction of new Managing Director

Brad thanked Gillian McFee and introduced Kevin Robbie

8. Creating Meaningful Impact

Kevin Robbie, from Think Impact the organisation will be leading a major co-op engagement process to develop an outcomes framework that will link the activities that both co-ops and CEHL do to achieve the outcomes we want to achieve.

Through this process the focus on building member skills and be able to articulate the value of co-op housing for members, the program and community.

9. Program Report

Nicola Foxworthy, Program Director, delivered the CEHL Program Report.

- Acknowledging co-op members for their contribution into CEHL processes.
- Thanking the Training Advisory Committee, that there has been some positive training activity this year.
- Thanking the Newsletter Advisory Group for publishing more co-op and member focused articles and increasing readership.

Advocating for a better housing system

- With other Housing Associations we have been actively advocating proposals to government for further investment in social and affordable housing with the Premiers announcement last weekend of over \$5b to create over 12,000 homes and tens of thousands of jobs.
- We are also active in the Affordable Housing Industry Advisory Group (made up of key property industry players) to advise government on ways to increase affordable housing through making changes to the planning system

Managing COVID impacts - CEHL ability to quickly respond

- CEHL was well prepared to make a quick response to the impact of COVID with Business Continuity Planning and investment in systems and technology enabled a smooth transition to work remotely.
- Our income-based rent model could immediately respond to people who lost income through adjusting
 their rents and CEHL has actively worked with co-ops to ensure they could continue to operate,
 providing responsive information as COVID rules changed, enabling co-ops to manage their
 requirements remotely and contribute to Program engagement.

Training and resources have been developed and provided to Co-ops to ensure they are ready to
respond to significant changes occurring in the RTA. COVID has impacted the timelines for these
changes, so this work will continue into the coming year.

Co-op Future Directions Plans driving outcomes

• Co-ops have been progressing their FDP plans, and to see how the planning process is helping co-ops identify actions for their property portfolio and co-op governance.

Co-op transition

A number of co-ops decided to transition co-op models from CERC to CMC. For those co-ops, the
transition is the culmination of significant work by co-op members to consider their capacity and
priorities and represents them making an active choice about the Co-op model that suits them best.
The CDS team worked with those Co-ops to ensure they understood their options and implications of
their choices.

\$1M boost to major works and upgrades

- We delivered an additional \$1m in maintenance works compared to last year. This included 39
 additional Third Schedule jobs (upgrades and major works) funded by the additional \$550k CERC
 company rent CEHL received from the rent model change.
- The Asset Team have also been working with the Community Housing Industry Association (CHIA) to clarify how energy efficiency measures for homes can be incorporated into maintenance delivery.

Nicola Foxworthy answered a question submitted from a Co-op regarding the program report.

10. Financial and Directors Reports

Brad Hosking delivered the Corporate and Financial report.

Organisational development

- Securing \$15M long-term & lower-cost financing and maintaining investment in Program properties
 with \$7.12M Maintenance Stimulus grant funding for over 500 homes (2020-2022) and \$10.1M Grant
 funding under the Victorian Government Big Housing Build to help fund 50 new program homes under
 construction.
- Delivering financial benefit to the Program with \$476k net income from Capital Investments.

Technology Investment

Three years of investment in technology systems enabled continuity of services to co-ops & members
during COVID-19 restrictions with the benefit of our 3-year investment in technology and the ability to
work remotely.

Financial Report

- We met our loan interest & any required repayments & loan conditions, including an acceptable level of interest cover (ICR).
- We maintained our investment in program properties and applied operating surplus to repay debt or holding those funds for property development and acquisition.
- CEHL's Revenue of \$22.1m is \$3.4m above last year. This includes rent revenue of \$15.1m (which was the same as the previous year and that was due to the rent moratorium). Revenue also includes grant income of \$2.7m [Wilson Ave VPF \$1.2m, Maintenance stimulus \$1.3m, SHGF \$250k] and includes gross income of \$628k from capital investments, noting that this excludes rent retained by CERCs.
- CEHL's administrative expenses are consistent with last year. There was an increase in employment
 costs due to Award rate increases but was mostly offset by lower legal fees and reduced motor vehicle
 costs.
- Finance costs of \$1.1m were consistent with the prior year.

- Depreciation was down slightly, this is mostly MV depreciation and the amortisation of IT software costs.
- Property expenses were up 66% by an amount of \$4.1m to a total \$10.3m. The key drivers of the cost increase were due to an additional \$2.7m of maintenance expense (including \$1.3m of maintenance stimulus works), an increase in insurance costs of \$133k and a significant increase to Council Rates of almost \$600k.
- We recorded a gross operating surplus of almost \$1.3m. The overall surplus for the year was \$100m, due a significant increase in the value of property assets, highlighting the challenge of a tight and increasingly expensive housing Victorian market.
- Brad spoke to the application of program revenue detailed in the annual report.

Brad Hosking answered questions submitted from co-ops regarding the financial statements.

11. Financial Statements & Auditor Appointment Motions

Brad Hosking presented the two motions to the members.

THAT the Annual Financial Statements for the year ended 30 June 2021, together with the Directors' Report and the Independent Auditor's Report in respect of those financial statements be received.

AND

THAT PKF be appointed as CEHL's auditor for the 2021-2022 financial year.

This vote was carried out by Zoom Poll and Brad Hosking confirmed that both motions presented were passed.

12. Election Results

Samantha Winter (scrutineer) announced that we have a tied vote for Judy Reid of Phoenix CERC and Robyn Evans of Merri CERC, and we are required to conduct an additional vote via Zoom poll for those authorised by their co-ops to vote.

The meeting had a 10-minute break for the second round of voting.

Robyn Evans apologised that she had to leave the meeting and thanked the members and congratulated the returning and new directors, and expressed that if she is not returned, she has enjoyed her time on the board.

Brad Hosking asked Samantha Winter to confirm that the second round of voting was completed. This was confirmed and Samantha Winter advised that Heidi Lee and Fiona Herman are returned as an Elected Directors to the CEHL Board and that from the result of the tied election vote, that Robyn Evans is returned as an Elected Director to the CEHL Board.

Brad Hosking congratulated the returning Directors and thanked Judy Reid for her nomination.



Co-op Program Committee and Strengthening the Member Voice Project

The Co-op Program Committee (CPC) is a committee of the CEHL Board established to advise the Board on member views about the Co-op Program.

Following a 2-year review of CPC, the Board asked CPC to consider options for strengthening the voice of Member Co-ops, and their members, in the Co-op Program. The major recommendation CPC made to the Board in the review was that the member voice needed to be strengthened by making sure CPC membership was representative of all Co-ops.

Having a strong, accountable member voice embedded in the international co-operative values and principles is critical in building trust between CEHL, Member Co-ops and their members. Doing this well also strengthens CEHL's corporate governance.

The Board has given CPC six months to undertake this project, with a report expected early in 2023.

CPC has arranged engagement activities to make sure we hear the voice of Co-op members.

These activities include:

- 8 face to face regional consultations (10th October 14th November)
- An online focus group with newer Co-op Members (< 5 years)
- An online survey seeking feedback on Member Voice options and
- A CPC presentation and breakout groups at the AGM

We need to hear different views about how to strengthen the Member Voice.

The Story So far....

From the regional forums held so far, there has been strong support for the idea of a Co-op Council and regional councils organised around 9 regions. Members are telling us that the focus must be on being heard and building trust between Member Co-ops and CEHL. For this to happen, a Co-op Council must be independent, with clear roles and responsibilities, good governance, be adequately resourced and have a chairperson. We are also hearing that re-building trust must start at the regional level, by encouraging co-operation between Member Co-ops in regions.

Join CPC Members at the AGM to learn more about the project on Strengthening the Member Voice.

CPC Members will make a short presentation at the AGM about options being considered, including challenges and opportunities that have been raised at the Regional Consultations.

Following the presentation, a CPC member will facilitate smaller groups of members to give feedback and answer some questions that will help CPC prepare a report to the Board before the end of the year.
