have your say about the rent model consultations, policy drafts, heater recalls, and opportunities to pilot a new allocations approach in some of our regions.

Our Co-op Housing Program is founded on the International Principles of Co-operation, requiring members to have a voice, and respectfully use it. Since embarking on the development of the Program Principles about two years ago, you will have noticed a shift in how CEHL and co-ops are seeking ways to enable program stakeholders to have an increasingly equitable opportunity to have a say. Taking the time to participate in our co-ops' good governance making transparent and informed decisions, and at a Program level through taking the time to respond to important consultations such as workshops, discussions, surveys etc.

The Rent Model Advisory Group (RMAG) is the current 'big consultation' item on which we need to share our thoughts, experience and knowledge. Thanks to those of you who have taken the time to attend a workshop or respond to the survey. If you are yet to have your co-op's voice is included, please ensure you do so! The CEHL Board recently received a briefing from the RMAG Chair who confirmed the capacity and work of the RMAG to date, and their belief in the value of this process, feedback which heartens the CEHL Board Directors and affirms for us, that we are on the right track in delivering on partnership beyond the rhetoric.

The upcoming Engagement Review is another important consultation to be active in. The Board wants to hear about which elements of our Program you seek to influence, how this might be activated, and what capacity needs to be supported to enable real and appropriate member influence.

You will hear more about this in the coming months, so please start the discussion about what Program engagement means for you at your co-op meetings. Think about how we work collaboratively, with the good of all our members at the forefront in our conversations.

I can see a vibrant item for our co-op meeting agenda's, and a topic which I hope elicits the warm fuzzy feelings of co-operation in us all.

The CEHL Co-op Conference will be upon us soon. Get the 15th of June in your diary now! I'm excited to be there to talk with you about how we make this a truly co-op led program and how the empowering and inclusive elements of co-operative living will continue to provide secure and appropriate affordable housing for our diverse communities.

Managing Directors Report

The recent Community Housing Industry Association (CHIA) Conference keynote speaker gave informed insight into what the Canadians did, behind the scenes, to encourage their government to take serious action on housing affordability.

The public debate and disquiet about housing affordability in Canada has been very similar to here. Public concern and media attention focused on the reality that emerging generations are struggling to afford housing, both rental and home ownership.

Local business associations started speaking out on the economic impact of the lack of affordable housing, and an unprecedented alliance emerged across sectors that don't traditionally campaign together.

Their key message was simple and effective:

the lack of affordable housing impacts the health of the economy and the health of the community

A comprehensive package of reforms and \$40 billion budget commitment was made and now the sectors are busily working on implementation.

This inspiring example made me reflect on what we can do in this state election year to promote co-operative housing as a key part of the solution to Victoria's housing affordability challenges and the embarrassing and devastating fact that Victoria now has the lowest proportion of social housing in Australia.

I am actively working with our peak body Community Housing Industry Association of Victoria (CHIA Vic) and with Housing Association CEOs to develop solutions and seek a new approach to partnering with government.

In the meantime, the Victorian Government has nearly finalised the key frameworks and will soon invite Housing Associations and Housing Providers to opt-in to the Victorian Housing Register. Currently there is no specificied deadline to decide, so we will have time to engage with co-ops at the upcoming CEHL Conference about the opportunities and concerns with the revised policy approach.

I am aware that many co-ops are making progress with your Future Direction Plans. This important work, when completed, will inform our property



portfolio planning including acquisitions and developments in each region. If you find that your co-op needs help to complete this work, please contact your Co-op Development Co-ordinator for assistance.

The new CEHL website is now up and running and I look forward to this being key tool which will provide more meaningful resources to co-ops.

You will hear a key theme throughout this year about the desire for the Housing Program to be more co-op led, this is a genuine commitment by the CEHL Board. Currently we have incomplete, informal and contradictory information about how, when and what co-ops want to be engaged about Program decisions. Through the upcoming Engagement Review you will be able to shape what and how much engagement will be essential to be a truly co-op led program. Your co-op input into this project will provide a roadmap for how we work together and continue to shape and grow this amazing Housing Program.


CEHL Training Review

The survey responses have been used to develop a set of recommendations to guide planning for future training. The recommendations are as follows . . .


 CEHL and Co-ops work together to identify how we can each ensure that co-op members are supported to build and maintain up-to-date skills and knowledge



Findings

- High level of interest in training
- Strong support for the training program offered in 2017 What is a Co-op and Roles and Responsibilities of Coop Directors
- Most respondents intend to participate in further training planned for 2018

Top 2 reasons why survey respondents have been unable to attend training

- 1. Had other committments
- 2. Date and time inconvenient

Top 3 ideas from survey respondents to increase training attendence

- 1. More variety of days and times for training
- 2. More local venues
- 3. More notice of upcoming training events

Training Recommendations

- Face-to-face training sessions planned for 2018 to proceed
- 2. Future training sessions to include:
 - More detailed information about the content of planned training
 - Early notice of upcoming training sessions, issued as widely as possible
 - · Reminders sent to registered attendees
 - Content to incorporate Plain English and practical applications
 - Opportunities for member involvement in delivery be explored

Co-ops Nurturing Leadership Skills

Growing up in Castlegreen Housing Co-operative, Ontario, Canada Sarah Jensen can't remember a time before she started volunteering. At 7, she was sweeping up after community events. At 14, she became the co-op's Community Garden Coordinator, and at 18, she became the youngest person ever to join her co-op's Board of Directors.

She credits her involvement to the support and mentorship of her fellow co-op members: "I've felt the support of my community more times than I can count, and I honestly believe that the aspect of encouragement and belief in other people is one of the most amazing things about cooperatives."

In order to help other youth get involved like she has, she also created a Youth Committee at Castlegreen. "Sarah continues to recruit youth in our community and encourages many to become engaged in our co-operative. We are very happy to have Sarah a part of Castlegreen Co-op and strongly support all of her efforts," says Sharon McKinnon, Castlegreen's General Manager.

Castlegreen is a 215-unit townhouse-style co-op in Thunder Bay, Ontario, which features a community centre, basketball court, ice rink, arboretum, computer lab, community garden, and a pick-up point for the Good Food Box Program. The co-op publishes a monthly newsletter and often brings members together for activities ranging from pancake breakfasts to clothing swaps.



After getting started volunteering in her co-op, Sarah started to get involved in the wider co-op movement. After attending the Ontario Co-operative Association's Co-operative Young Leaders program (CYL), Sarah began volunteering with the Northwestern Ontario Regional Manager for On Co-op. She has been managing the regional Facebook page, as well as speaking at high schools about

co-ops, and attending local co-op business seminars and conferences.

It's clear that by nurturing Sarah's leadership abilities and sense of community, Castlegreen Housing Co-op has developed a lifelong co-op advocate in Sarah Jensen.

As she puts it, "I don't think anything can be more special than the place your co-op takes in your heart."



Medicinal Herbs

Please consult your General Practitioner before taking any of these or other medicinal herbs to ensure they are not contraindicated with any medication you might be taking.

Aloe vera

<u>Parts used</u> leaves, externally for skin irritations, rashes as well as for mild sunburn.

Calendula officinalis

<u>Parts used</u> Petals digestive tonic, externally skin treatments, wounds, burns, and beauty treatments.

Chamomiles Roman form
Chamaemelum nobile, or the German form Matricaria recutita
Parts used Flowers as a mild sedative, calms nausea, external use for itches, inflamed skin and rashes.

Ginger Zingiber officinale
Parts used Root system, calms some
forms of nausea, indigestion and colic,
possibly lowers cholesterol.

Hops Humulus lupulus

Parts used Female flowers, as a mild sedative, calming, helps improve sleep.

Lavender Lavendula angustiflolia or officinialis

<u>Parts used</u> Flowers, may be used for oil or oil mixed with water (lavender water) for perfume, relaxing baths, or showers, use lavender water for sleep pillows and insect repellent. Avoid applying oil to skin as it may cause burns.

Lemon balm Melissa officinalis
Parts used Leaves as a digestive tonic
or a calming drink.

Rose hip Rosa sp.

Parts used Hips/herps which are the seed pods. Seeds can be used as diuretic, oil from hips can be used as a skin treatment, and the juice is used for Vitamin C.

These were engaging and lively discussions that provided the Rent Model Advisory Group (RMAG) with valuable feedback from members as it continues to work towards the development of recommendations for a revised rent model that will go to the CEHL Board in September 2018.

Swimming and Spa Pools – Building Regulation Changes

There have been a number of changes to Building Regulations this year which are effective from 2nd June 2018. In Victoria, the design, construction and installation of swimming and spa pools and their safety barriers are subject to strict building requirements and require a permit. A permit must be obtained prior to any work going ahead.

If a tenant member wishes to install a pool or spa or make any other modification, they must complete a Tenant Funded Modification Request Form and forward it to their co-op for



approval, and then forward to CEHL for consideration. Requests for pools and spas are however unlikely to be approved because of the significant safety and compliance obligations involved.

If a pool has been installed without going through this process and appropriate safety barriers have not been installed, it must be emptied immediately as it will be in breach of the regulations! The relevant Council may be contacted to inspect the pool to assess its compliance.
